AGM Treasurer's Report

April 2019

### Tavistock Community Health Inc. ended the 2018 fiscal year Dec 31, 2018.

The net loss for the year being \$3,678. Represents Page 7 (- \$5,336 page 8 +\$1,658 )

However, some of the items on the income statement were non-cash (meaning nothing was paid or received). After removing transactions with TMCL (Tavistock Medical Centre Limited (a wholly -owned subsidiary of TCHI) removing amortization, considering TMCL expenses paid for by TCHI, and adding capital purchases in the year, TCHI would end up with a net cash increase.

However, to sustain the organization in the long term, TCHI must look for future increases in Revenue.

We continue to review Rents on an annual basis, review our operating budget monthly & have worked on a Five Year capital budget. Seventeen years have passed without active fundraising so we have designed a New Brochure which is being circulated throughout the broader community to build on Donations, our hope is that the target of \$80,000. can be reached by the end of 2019.

Also through our website <u>www.tchi.ca/donations</u> we offer payment by way of Pay Pal , Cheque or credit card offered by CanadaHelps.org

#### **Fundraising Committee Report**

In 2002, a successful fundraising drive resulted in the formation of Tavistock Community Health Inc. (TCHI). TCHI became the community non-profit organization that owns and maintains the property and building that houses the medical clinic.

During the past year, the TCHI Board developed a five-year capital expense budget. If this budget is accurate, reserves held by TCHI will be depleted by 2023. The board has taken action on several fronts to increase revenue, but government funding cuts still have a negative impact. Therefore the fundraising committee was instructed by the board to initiate fundraising efforts in the community.

A brochure was created explaining how TCHI functions and the need for community financial support. This brochure was sent to all Tavistock and surrounding community residents soliciting donations. A letter containing much of the same information has also been sent to all the local service clubs and to all former TCHI Board members.

Early responses have been very favorable. We believe that generous giving will help insure sustainable health care in our community long into the future.
